BACK TO SCHOOL 2022 SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. SPONSOR INFORMATION: Golden 1 Credit Union, located at 8945 Cal Center Dr., Sacramento, CA 95826, is the sponsor of this Sweepstakes (“Sponsor”).

2. ELIGIBILITY: This Sweepstakes is open only to legal residents of California 18 years of age or older who are members of Golden 1 Credit Union on or before August 13, 2022 and who are themselves students or have a child who is a student (verification required). You need not be present to win. Employees (and their immediate families or those living in the same household) of Sponsor are eligible to enter or win. Limit one (1) Prize per winner.

3. HOW TO ENTER: This Sweepstakes begins at 9:00 a.m. PST on, August 15, 2022, and ends at 11:59 p.m. PST on August 26, 2022. You may enter this Sweepstakes through the following method: Attending one Webcast between the dates of August 15 – 26, 2022 and completing our module in the Learning Lab (www.golden1.com/FinancialWellness). After finishing the Back-to-School module an entry form will appear where participants can enter to win. There will be one (1) entry allowed per person. Multiple entries received from any person beyond this limit will void all such additional entries. From all valid entries, four (4) winners (3 non-employees and 1 employee) will be randomly selected via Woobox generator. All entries must be received by 11:59 p.m. PST on August 26, 2022. You may be required to provide some or all of the following information: your first and last name, date of birth, email address, and student status verification to claim the winning Prize. Entries made by any individual or any entity other than the named entrant and/or originating at any other Internet website, including (but not limited to) commercial sweepstakes subscription notification and/or entering service sites, are void. Entries generated by a script, macro, or other automated means or by any means that subvert the entry process or interfere with fair play of this Sweepstakes will be disqualified.
