A's June 2026 Ticket Sweepstakes - Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

SPONSOR INFORMATION: Golden 1 Credit Union, located at 8945 Cal Center Dr., Sacramento, CA 95826 is the Sponsor and prize provider of this sweepstakes. Rules are subject to change without notice. Terms and conditions apply.

ELIGIBILITY: This Sweepstakes is open only to residents of the United States who are 18 years of age or older. You need not be present to win. At the time of prize drawing and awarding, you must be a Golden 1 member in good standing, as described in your Disclosure of Account Information and Membership Agreement. Employees of Golden 1 and their household members, and Golden 1 board members and their immediate family (spouse, parents, siblings and children) are ineligible to participate.

HOW TO ENTER: The "Sweepstakes Period" is from May 18, 2026 to May 31, 2026. You may enter this Sweepstakes by using the entry form on Golden 1's social media channels (Facebook, Instagram, and X) as described below. All entrants must complete all lines on the form to be eligible. There will be one (1) entry allowed per person. Multiple entries received from any person beyond this limit will void all such additional entries.

From all valid entries, 7 will be randomly selected. All entries must be received by 11:59pm on May 31, 2026. You may be required to provide some or all the following information: your first and last name, date of birth, email address, and phone number to claim the winning prize. Entries made by any individual or any entity other than the named entrant and/or originating at any other Internet website, including (but not limited to) commercial sweepstakes subscription notification and/or entering service sites, are void. Entries by any means that subvert the entry process or interfere with fair play of this Sweepstakes will be disqualified. Instagram entrants must be the registered subscriber of the Instagram account through which the entry is made. In the event of a dispute as to entries submitted by multiple users having the same Instagram account, the person whose email address and/or phone number associated with the Instagram account used to enter the Sweepstakes at the actual time of entry will be deemed to be the entrant.

X ENTRY METHOD: During the Sweepstakes Period, you may enter the Sweepstakes via x.com/golden1cu by following the link included in the X posts between May 18, 2026 to May 31, 2026. You may be required to provide some or all the following information: your name, age, address, city, state, zip code, telephone number, and e-mail address. X entrants must be the owner or delegated owner of the X account by which the entry is made. In the event of a dispute, entries made by the person to whom account access was delegated at the time of Sweepstakes will be deemed the entrant.
