Summer RV Loan Sweepstakes Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

SPONSOR INFORMATION: Golden 1 Credit Union, located at 8945 Cal Center Dr., Sacramento, CA 95826 is the Sponsor and Prize Provider of this sweepstakes (“Sponsor”) (“Prize Provider”). Rules are subject to change without notice. Terms and conditions apply.

1. ELIGIBILITY: This sweepstakes is open only to residents of the United States who are 18 years of age or older. You need not be present to win. Employees of Golden 1 and its respective parent and affiliate companies, as well as board members and the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. At the time of Prize drawing and awarding, you must be a Golden 1 member in good standing, as described in your Disclosure of Account Information and Membership Agreement.

2. HOW TO ENTER: The “Sweepstakes Period” is from May 1, 2026, to June 30, 2026. Eligible entrants will receive one (1) entry into the Sweepstakes for the following actions made during the Sweepstakes Period (each a “Qualifying Transaction”):

Recreational Vehicle (RV) loan applications received between 5/1/2026 and 6/30/2026 that result in a funded RV loan no later than 7/15/2026 are automatically entered into the sweepstakes. Applications that do not result in a funded loan are eligible for a sweepstakes entry by written request (see below for how to enter by mail).

The Qualifying Transaction will result in one (1) entry per member. Entries that are late, incomplete, or incorrect for any reason, including, without limitation, computer or network malfunction, are void and will not be accepted.

The envelope must include their contact information, including name, email address, and phone number and be postmarked by 5:00 p.m. Pacific Time on June 30, 2026.

Automated means of entry are prohibited and any use of automated devices to enter or subvert the entry process will result in disqualification and all associated entries will be void.

3. PRIZES: Prize winners will be selected in a random drawing from all eligible entries. A total of ten (10) members will receive one (1) California Explorer Vehicle Day Use Annual Pass and \$250.00 in the form of a deposit into the account of each winner. Total value of all prizes: \$445.00.

4. RANDOM DRAWING: Prize winners will be selected in a random drawing from all eligible entries received on or about July 22, 2026. Odds of winning are equal regardless of the method of entry and depend on the number of eligible entries received. The winner will be notified by phone and/or email.

5. PRIZE CONDITIONS: Winners are subject to verification, including verification of age. The potential prize winners will be required to complete, sign, and return an Affidavit of Eligibility/Liability Release, and, where lawful, a Publicity Release (granting the use of the winner's name, city/state, likeness, or photograph by Sponsor for advertising/publicity purposes, without further compensation) within seven (7) calendar days of attempted email and phone notification or prize may be forfeited and an alternate winner may be contacted. If winner is an eligible minor in his/her state of residence the prize will be awarded to the eligible minor's parent or legal guardian, who must sign and complete the Affidavit of Eligibility/Liability Release, and, where lawful the Publicity Release on the minor's behalf. Sponsor is not responsible for any change of mailing address, email address and/or telephone number of entrants. Prizes may not be awarded if the prizes are not properly claimed. Members will be notified that they won via email and/or by telephone. Prizes will be delivered in person at one of the Sponsor's locations or to the email associated with your account within ten (10) business days of verification.

Your participation in this sweepstakes constitutes your consent for the Sponsor and Prize Providers to use your personal information for the purpose of administering the sweepstakes and awarding the Prize. The Sponsor's or Prize Providers' failure to enforce any term of these Official Rules shall not constitute a waiver of that term or any other provision.
