OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. SPONSOR INFORMATION: Golden 1 Credit Union, located at 8945 Cal Center Dr., Sacramento, CA 95826 is the Sponsor of this sweepstakes (“Sponsor”). The prize is provided by Fiserv Solutions, LLC, 255 Fiserv Drive, Brookfield, WI 53045 (“Prize Provider”) Terms and conditions apply.

2. ELIGIBILITY: This sweepstakes is open only to residents of the United States who are 18 years of age or older and a member, in good standing, of Golden 1 Credit Union on or before March 3, 2024. You need not be present to win. Employees of Golden 1 and its respective parent and affiliate companies, as well as board members and the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. Rules are subject to change without notice. Terms and conditions apply.

3. HOW TO ENTER:

Golden 1 Credit Union accountholders in good standing (not in default under their Membership Agreement as of March 3, 2024) will receive one (1) entry into the sweepstakes (“Sweepstakes”) for each one (1) of the following actions made during the Sweepstakes Period (each a “Qualifying Transaction”). Qualifying members are permitted to complete all three types of Qualifying Transactions for up to three (3) entries per member. Entries that are late, incomplete, or incorrect for any reason, including, without limitation, computer or network malfunction, are void and will not be accepted. The “Sweepstakes Period” is through March 3, 2024.

The Qualifying Transactions are:

- Download Golden 1 Mobile Banking app.
- Add and complete an inbound transfer from a new external account. Qualifying transfers must be at least \$50.00 moved between a newly added TransferNow external account and a qualified account at Golden 1 Credit Union, and new registration qualifiers must complete the add-and-verify account process.
- Complete a mobile check deposit using Golden 1 Mobile Banking app.

All Qualifying Transactions must be completed by a qualifying member during the Sweepstakes Period. A qualifying member is a member who is completing a Qualifying Transaction for the first time. All entrants must be the primary accountholder of the Golden 1 Credit Union account associated with the action used to enter the Sweepstakes. In the event of a dispute as to who submitted an entry, the natural person associated with the email account used for entry will be considered the entrant, but only if that person is otherwise eligible to enter the Sweepstakes.

3. PRIZES:

Prize winners will be selected in a random drawing from all eligible entries. A total of ten (10) members will each receive \$1,000 in the form of a deposit into the account of each winner. Total value of all prizes: \$10,000.

Automated means of entry are prohibited and any use of automated devices to enter or subvert the entry process will result in disqualification and all associated entries will be void.

By participating in the Sweepstakes, entrants agree to the Official Rules and Golden 1 Credit Union's decisions, which are final and binding in all respects. 4. RANDOM DRAWING: Prize winners will be selected in a random drawing from all eligible entries received on or about March 3, 2024. Odds of winning are equal regardless of the method of entry and depend on the number of eligible entries received. The winner will be notified by letter.

5. PRIZE CONDITIONS: Winners are subject to verification, including verification of age. The potential Grand Prize winners will be required to complete, sign, and return an Affidavit of Eligibility/Liability Release, and, where lawful, a Publicity Release (granting the use of the winner's name, city/state, likeness, or photograph by Sponsor for advertising/publicity purposes, without further compensation) within seven (7) calendar days of attempted mail notification or prize may be forfeited and an alternate winner may be contacted. In the letter, members will receive an W9 from requesting their completion and return. Once the W9 form is returned and processed, Golden 1 will direct deposit prize funds into the members account. Prizes will be deposited into the members account within 6-8 weeks of verification.

6. ODDS OF WINNING: Odds of winning the Prize are equal regardless of method of entry and depend on the total number of eligible entries received.

Your participation in this sweepstakes constitutes your consent for the Sponsor and Prize Providers to use your personal information for the purpose of administering the sweepstakes and awarding the Prize.
