

## **2025 SUMMER YOUTH SAVINGS SWEEPSTAKES**

### **OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**ELIGIBILITY:** This Sweepstakes is open only to residents of the United States who are 18 years of age or older and members, in good standing, of Golden 1 Credit Union with a Youth Savings account on or before July 31, 2025. To be eligible, deposit at least \$100.00 in your Youth Savings account between April 15, 2025 - July 31, 2025. You need not be present to win. **HOW TO ENTER:** This Sweepstakes begins at 12:01 AM PST, April 15, 2025. The steps to enter are as follows:

1. **Make a Deposit:** Make a deposit of at least \$100.00 into a Youth Savings account between April 15, 2025 - July 31, 2025, to be automatically entered to win.

There will be one (1) entry allowed per person. From all valid entries, ten (10) winners will be randomly selected. All entries must be received by 11:59 PM on July 31, 2025. You may be required to provide some or all of the following information: your first and last name, date of birth, email address, and phone number to claim the winning Prize. Each winner will receive a match of the deposits made into their Youth Savings account between April 15 - July 31, 2025, up to \$500, in the form of a deposit into their Youth Savings account.
