DIGITAL SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. SPONSOR INFORMATION:** Golden 1 Credit Union, located at 8945 Cal Center Dr., Sacramento, CA 95826 is the Sponsor of this sweepstakes (“Sponsor”). The prize is provided by Fiserv Solutions, LLC, 255 Fiserv Drive, Brookfield, WI 53045 (“Prize Provider”) Terms and conditions apply.
- 2. ELIGIBILITY:** This sweepstakes is open only to residents of the United States who are 18 years of age or older and a member, in good standing, of Golden 1 Credit Union on or before May 31, 2026. You need not be present to win. Employees of Golden 1, as well as board members and the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. Rules are subject to change without notice. Terms and conditions apply.
- 3. HOW TO ENTER:** Golden 1 Credit Union accountholders in good standing as of May 31, 2026 as defined in the Golden 1 Disclosure of Account Information and Membership Agreement, will receive one (1) entry into the sweepstakes (“Sweepstakes”) for each one (1) of the following actions made during the Sweepstakes Period (each a “Qualifying Transaction”). Entries that are late, incomplete, or incorrect for any reason, including, without limitation, computer or network malfunction, are void and will not be accepted. The “Sweepstakes Period” is through May 31, 2026.

The Qualifying Transactions are:

- **Up to 1 entry for logging into Online or Mobile Banking during the campaign period.**
- **1 entry for every Bill Pay transaction during the campaign period. Qualifying Bill Pay transactions include:**
 - Add and pay a new bill. Qualifying Bill Pay transactions must be at least \$10.00 and must be sent to a unique party with a different mailing address from the Bill Pay subscriber; payments to oneself are excluded.
 - Activate an eBill.
 - Set up a new auto payment for eBill.
 - Set up a new recurring payment.
- **1 entry for every TransferNow (External Transfer) transaction during the campaign period:**

- Add and complete an inbound transfer from a new external account. Qualifying transfers must be at least \$50.00 moved between a newly added TransferNow (External Transfer) external account and a qualified account at Golden1, and new registration qualifiers must complete the add-and-verify account process.
- **1 entry for every Zelle® transaction during the campaign period:**
 - Add and pay a new Zelle® contact. Qualifying Zelle® payments must be at least \$5.00 and paid to a third party with a different mailing address from the primary online banking accountholder to whom the payment is made. Terms and conditions apply. Zelle® and the Zelle® related marks are wholly owned by Early Warning Services, LLC and are used herein under license.

All Qualifying Transactions must be completed during the Sweepstakes Period. All entrants must be the primary accountholder associated with the action used to enter. In the event of a dispute as to who submitted an entry, the natural person associated with the email account used for entry will be considered the entrant, but only if that person is otherwise eligible to enter the Sweepstakes.
