## PROPOSED TRANSITION TO AUDIT COMMITTEE

At the June 29, 2023 regular Board meeting, the Golden 1 Credit Union Board of Directors resolved to establish an Audit Committee in lieu of a Supervisory Committee. An Audit Committee would perform the legally required oversight functions similar to the Supervisory Committee today, including with regard to financial reporting, internal controls, audits, and such other responsibilities as may be delegated to the Audit Committee by the Board of Directors. One primary difference is that Audit Committee members are appointed by the Board, and a majority of Audit Committee members must be Directors. The Board determined that the Audit Committee structure would facilitate closer alignment of the Board's strategic decisions with audit and internal controls oversight, and effectively position the Credit Union for future growth.

Before the Board's action is effective, it must be affirmed by the membership. Therefore, at the Annual Meeting of the Members on March 21, 2024, the members will vote on whether to affirm the Board's vote to establish an Audit Committee consisting of an odd number of not less than three (3) nor more than seven (7) persons as fixed by resolution of the Board.
