RECEIVE UP TO \$20,000 FOR COLLEGE GOLDEN 1 CREDIT UNION SCHOLARSHIPS.

Applications for the Golden 1 Credit Union Scholarship Program will be accepted from mid-November through January 31, 2023. Scholarships are for students attending both two-year and four-year nonprofit, accredited colleges and universities in California during the 2022-23 school year. Awards range from \$1,000 to \$5,000 and are renewable annually for up to four years. We are proud to offer this benefit to eligible members and their dependents.

- 2. Election of Supervisory Committee members
- 3. Amendments of the Bylaws of Golden 1, except as prohibited by law
- 4. Any other matters which may properly arise at either the Annual Members' Meeting or any special meeting of the members. Notice of such matters shall be provided to the members in the notice of such meeting.
