OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **SPONSOR INFORMATION:** Golden 1 Credit Union, located at 8945 Cal Center Drive, Sacramento, CA 95826, is the sponsor of this Sweepstakes.

1. **ELIGIBILITY:** This Sweepstakes is open only to Members of Golden 1 Credit Union who are 18 years of age or older. You need not be present to win. Employees (and their immediate families or those living in the same household) of Sponsor are *not* eligible to enter or win. Limit one (1) Prize per winner.

All entries must be received by February 23, 2026, at 11:59 pm. You may be required to provide some or all the following information: your first and last name, date of birth, email address, and phone number to claim the winning Prize.
