

**GOLDEN 1 Q3 2026 CREDIT CARD  
SWEEPSTAKES OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**SPONSOR INFORMATION:** Golden 1 Credit Union, located at 8945 Cal Center Dr., Sacramento, CA 95826 is the Sponsor and Prize Provider of this sweepstakes ("Sponsor") ("Prize Provider"). Terms and conditions apply.

**1. ELIGIBILITY:** This sweepstakes is open only to residents of the United States who are 18 years of age or older and a member, in good standing, of Golden 1 Credit Union on or before October 4, 2026. All entrants must be the primary accountholder of the Golden 1 Credit Union account associated with the action used to enter the Sweepstakes (each a "Qualifying Member"). You need not be present to win. Employees of Golden 1, as well as board members and the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. Rules are subject to change without notice. Terms and conditions apply.

**2. HOW TO ENTER:** Golden 1 Credit Union accountholders in good standing, as defined within the Disclosure of Account Information and Membership Agreement, will receive entries into the sweepstakes ("Sweepstakes") for the following actions made during the Sweepstakes Period (a "Qualifying Transaction"). Entries that are late, incomplete, or incorrect for any reason, including, without limitation, **computer or network malfunction, are void and will not be accepted.** **The "Sweepstakes Period" is from 12:01 a.m (Pacific Time) on August 31, 2026 through 5:00 p.m. (Pacific Time) October 4, 2026.**

*Automatic Entry:* An eligible Visa cardholder will automatically receive one (1) Sweepstakes entry for each eligible Visa purchase made with one (1) of the following Golden 1 Credit Union Visa consumer credit cards: Member Cash Rewards, Member Cash Rewards+, Member Rate Advantage, Platinum Rewards Card or Member First Secured Card.

Qualifying Transactions:

- Earn 1 entry = For each purchase you make with your Golden 1 Credit Union **credit card**.
- Earn 10 entries = For each purchase you make with your Golden 1 Credit Union **credit card** equal to or greater than \$500.

Envelope must include his/her contact information, including name, email address, and phone number and be postmarked by 5:00 p.m. Pacific Time on October 4, 2026.

A qualifying purchase ("Qualifying Transaction") includes Point of Sale (POS) transactions that post to your account during the Sweepstakes Period. Qualifying purchases do not include credits, returns, other adjustments that are not payments, balances transfers, cash advances, items returned

for credit, unauthorized charges, interest and account fees, travelers checks, foreign currency purchases, money orders, wire transfers (and similar cash-like transactions), lottery tickets, gaming chips (and similar betting transactions). Direct deposits from the Golden 1 Member's employer, payroll provider, or benefits payer in the form of an Automated Clearing House (ACH) direct deposit do not qualify. Likewise, bank ACH transfers, Pay Anyone transfers, verification or trial deposits from financial institutions, peer to peer transfers from services such as PayPal, Cash App, or Venmo, mobile check deposits, and cash deposits do not qualify.

The Qualifying Transaction(s) must be completed by a qualifying member during the Sweepstakes Period. A qualifying member is a member who is completing the Qualifying Transaction.

**3. PRIZES:** Prize winners will be selected in a weekly random drawing from all eligible entries. Each week, a random drawing for 3 unique prizes of \$500, \$300, and \$100 will be deposited into (3) members accounts. Up to fifteen (15) members will receive \$500, \$300, or \$100 in the form of a deposit into the member's regular share account of each winner. Entries will restart each week. Actual odds of winning depend on the total number of entries received.

**4. RANDOM DRAWING:** Prize winners will be selected in a random drawing from all eligible entries received—during the Sweepstakes Period. Random drawing dates include the week of: September 7, 2026 (for entries submitted 8/31/26-9/6/26), September 14, 2026 (for entries submitted 9/7/26-9/13/26), September 21, 2026 (for entries submitted 9/14/26-9/20/26), September 28, 2026 (for entries submitted 9/21/26-9/27/26), October 5, 2026 (for entries submitted 9/28/26-10/4/26).

The winners will be notified by phone from their local Golden 1 Credit Union branch and notified by email at the email address on the member file.

**5. PRIZE CONDITIONS:** Winners are subject to verification, including verification of age. The potential winners will be required to complete, sign, and return an Affidavit of Eligibility/Liability Release, and, where lawful, a Publicity Release (granting the use of the winner's name, city/state, likeness, or photograph by Sponsor for advertising/publicity purposes, without further compensation) within seven (7) calendar days of attempted mail notification or prize may be forfeited and an alternate winner may be contacted. If winner is an eligible minor in his/her state of residence the prize will be awarded to the eligible minor's parent or legal guardian, who must sign and complete the Affidavit of Eligibility/Liability Release, and, where lawful the Publicity Release on the minor's behalf. Sponsor is not responsible for any change of mailing address, email address and/or telephone number of entrants.
