2026 Back to School Student Sweepstakes - Official Rules

SPONSOR INFORMATION: Golden 1 Credit Union, located at 8945 Cal Center Dr., Sacramento, CA 95826 is the Sponsor and prize provider of this sweepstakes. Rules are subject to change without notice. Terms and conditions apply.

ELIGIBILITY: This Sweepstakes is open only to residents of the United States who are 13 years of age or older. You need not be present to win. At the time of prize drawing and awarding, you must be a Golden 1 member in good standing, as described in your Disclosure of Account Information and Membership Agreement. Employees of Golden 1 and their household members, and Golden 1 board members and their immediate family (spouse, parents, siblings and children) are ineligible to participate.
