**Automatically Renewable Account** - This account will mature as shown on your Term Share Certificate receipt. A notice will be mailed to you prior to the maturity of your certificate. For all products listed above, funds not withdrawn at the date of maturity will be reinvested to a Legacy Term-Savings Certificate Account (or Legacy Term-Savings IRA Certificate Account) with the same term length as the original account. The rate at renewal shall be the Legacy Term-Savings Certificate rate offered at the time of maturity. You may prevent renewal if you withdraw the funds in the account at maturity, or within the grace period, or if we receive written notice from you within the grace period. You will have a grace period of fourteen (14) calendar days after maturity to withdraw the funds in the account without being charged an early withdrawal penalty.
